- A. Discussion with Tom McMorran and Stephanie Pierson-Ugol on K-12 Continuum and Future of School:
  - Stephanie talked about the importance of focusing on middle school, where there are the most opportunities for innovation and disruptive strategies around schedules, structure of class periods, movement, and differentiation. The middle school years are when we start to lose learners.
  - Tom shared a resource "This We Believe" about Middle school, available at <a href="www.nmsa.org">www.nmsa.org</a>, as well as a Harvard Education Letter article "From Cells and Bells" to Learning Communities about the how physical structure impacts learning. There are opportunities to be creative with space and technology within the classroom as well as within the building. Classrooms as learning communities.
  - Tom also shared a theory of Richard Elmor from the Harvard School of Education on Achievement vs. Attainment.
  - A goal we should consider is that each student should be assisted in learning in the way that they do best and have greatest opportunity to succeed.
  - Focus on developing creative thinkers.
  - Factors to consider include space, personnel, curriculum, plan of study

- Dr. Josefsberg briefly reviewed presentations from Redding Long Range Planning meeting regarding how other districts are addressing declining enrollment. The committee will review in detail and we will have further discussion with Jonathan Costa at 12/9 meeting.
