Regular Meeting and Budget Presentation Minutes Helen Keller Middle School Learning Commons Tuesday, January 15, 2019 7:30 p.m.

CALL TO ORDER

Mr. Parker called the meeting to order at 7:30 p.m.

APPROVAL OF MINUTES

Motion: move that the Easton Board of Education approve the minutes of the December 11, 2018 Regular Meeting. Chieda, Bindelglass. Approved, 5-0. Hicks abstained.

PUBLIC COMMENT

Andy Kachele of Kachele Street, Easton: spoke about the importance of having the Board of Finance provide input during budget preparation to the Board of Education. He expressed concern about potential budget challenges we may face due to deficits in state budgets. In particular, Mr. Kachele pointed out that Easton property values are in decline and that Easton has one of the highest per capita tax rates in Connecticut. He proposed exploring ways to keep tax rates down and the BOE budget will continue to be reviewed and analyzed by the Board of Finance.

BOARD MEMBER COMMENT

Dr. Bindelglass thanked Andy Kachele for his excellent communication and help with starting to prepare the budget for 2019-2020.

BUILDING ADMINISTRATIVE REPORTS

Helen Keller Middle School: Mrs. Kaplan spoke about HKMS accomplishments, including Mr. Dolecki receiving the "Teacher of the Year" award, and band and music concerts. There will be a music extravaganza on January 18, 2019 and she invited board members to attend to view the performance given by students at HKMS in the auditorium.

Samuel Staples Elementary School: Mrs. Fox Santora spoke about the art teacher's unique and exciting project for Martin Luther King Day, celebrating the "I Have a Dream" speech. Mrs. Fox Santora praised the work of the SRO at SSES, reporting that he is working hard and is a welcome addition to the school.

Mr. Reiss reported that the HKMS gym subfloor was ready for use upon the students' return from the holiday break. The floor is safe for use now, and the final floor will be installed in the near future. Mr. Reiss said he is waiting for the insurance company's engineer's report to confirm the extent of the damage. With regard to the floor tiles in certain areas of HKMS, Mr. Reiss stated there is no change in status and he is waiting for an updated report from the insurance company's engineers.

DISTRICT ADMINISTRATIVE REPORTS

Dr. Pierson Ugol spoke about the importance of having a Science Technology Instructional Coach (STIC) to provide science curriculum and instructional support to the teachers. Mr. Reiss spoke about the Budget Object Summary and, and reported that next month's report would provide the Board with a better picture of the balance. Mr. Reiss stated that the health insurance claims are stable at this time. Mrs. Twiss reported that there has not been an increase in the number of special education students for this year. Dr. McMorran reported that he recently attended a legislators breakfast and proposed raising the threshold for excess cost of special education, enabling towns to receive financial assistance from state sources for students.

BOARD OF EDUCATION COMMITTEE REPORTS

Mr. Hicks reported there will be a new bus company as of August 2019. The new buses will have seat belts. Mr. Parker spoke about the meeting on January 22, 2019, when the Central Office Budget will be discussed. Mr. Reiss reported that the insurance company Brown and Brown will be putting their contract out for bid. They proposed exploring various ways to finance the health insurance plans.

PUBLIC COMMENT

None.

BOARD MEMBER COMMENT

Mrs. Chieda voiced concern about the public perception and timing of the passing of the Board of Education Budget and the Central Office Budget. Mr. Parker spoke about the May deadline for having a referendum on the budgets. He suggested preparing the Central Office budget ahead of time, perhaps during the summer, in the future. Dr. Bindelglass spoke about his concern that, without a newspaper, the public might not be reminded to vote. Dr. McMorran suggested a townwide mailing to remind people to vote.

ADJOURNMENT

Motion: move that the meeting be adjourned. Hicks, Reed. Approved. Unanimous.
