la. Animal Control

A new roof cable is included in Material & Supplies. Also, an annual stipend of \$2,400 paid to the ACO for cleaning the new kennel was more cost effective.

1b. Communication Dispatchers

Employee retiring this year and wages will be lower for the new employee due to the entry level position.

1c. Police Commission

The Chief gave an overview of the police department's personnel. The Chief reviewed the overtime budget stating 59% is for minimum manpower, 11% is mandated training, 12% special cases, 17% misc. to include storm related issues.

Also reviewed the five year capital plan and the issue of body cameras. Although the Chief does not see a need for body cameras in Easton but they are included in the capital plan as he believes that the State may mandate them in the future.

The purchase of vehicles was discussed in great detail. The Chief stated the police department needs to be on a 3 car/2 car/2 car cycle. The Police Commission would like the BOF to establish a Police Special Duty Fund for the purchase of police vehicles and a draft policy for this fund was discussed. The BOF will take this under consideration. The issue of transparency and having the tax payer vote on the purchasing of cars was in contention. No decisions at this time.
