BOARD OF FINANCE - MINUTES
Special MEETING and Budget Hearings
April 3, 2014 - 7:00 P.M.
Revised

Present: Chris Griffin-Chair, Matt Gachi, Andy Kachele, Paul Lindoerfer, Elise Nappi, Gabriel Rossi.

Absent: C. Lee Hanson, Fred Knopf-Clerk, Art Laske.

Also present: Adam Dunsby-First Selectman, Robert Lessler-Board of Selectmen, Scott Centrella -- Board of Selectmen, All Board of Selectmen members arrived at 8:30 p.m. Wendy Bowditch-Treasurer, Grace Stanczyk-Comptroller.

Chris Griffin called the meeting to order at 7:02 p.m.

Fred Knopf designated Elise Nappi and Lee Hanson designated Matt Gachi in their absence.

Paul Lindoerfer moved and Matt Gachi seconded a motion to have Gabriel Rossi fill in for Art Laske in his absence. Motion carried unanimously.

The Board discussed with the Bernard Josefsberg Superintendent the 2014-2015 education budget. He stated that the .3 social worker (\$24,000) would be eliminated and the social worker would remain at the present status. The intention is to begin the "World Language Program". The WiFi will be completed in the 2013-2014 budget year.

At this time, the Superintendent left the meeting and the Board will continue the discussion later in the meeting.

Chief Candee reviewed the 2014-2015 budget with the Board. The Board did not approve another officer at this time. The department will remain at 9 officers. The following lines will be adjusted as follows:

Police regular wages	03601000-5111	-\$51,837
Police Holiday	03601000-5114	-\$3,344
Police Services & Fees	03602000-5200	-\$1,161
Police Education	03606000-5600	-\$1,500
Police Pre-Testing	03622000-5022	-\$1,015
Police Clothing	03626000-5026	-\$4,250

The sale of the vehicle revenue will go to general fund revenue and will not offset the capital outlay budget line as it has been done in the past.

After discussion Elise Nappi moved and Paul Lindoerfer seconded a motion to adjust the Board of Education's budget in the amount of \$87,500 (splitting the difference of larger scenarios). This amount added to the \$90,000 health insurance savings to make a total cut of \$177,500.


Elise Nappi, Paul Lindoerfer, Gabriel Ross, voted yes and Matt Gachi and Andy Kachele voted no. Motion carried.

Andy Kachele moved and Paul Lindoerfer seconded a motion to recommend to a town meeting a 2014-2015 budget in the amount of \$42,093,878 consisting of Town Departments in the amount of \$15,631,836 with Capital outlay of \$540,535 and the Board of Education budget included in this amount is \$15,503,766 and the Region 9 budget included in this amount is \$10,417,741.

This represents a 2% tax impact using \$280,000 of surplus.

Andy Kachele moved and Paul Lindoerfer seconded a motion to adjourn at 9:29 p.m. Motion carried unanimously.
