Val Buckley presented Senior Center budget. We discussed external grants and Easton Senior Center Inc. 501(c) 3 funding, transportation needs, custodial needs.

Gerry presented Insurance budget. We discussed move from CIRMA to Travelers, and rate changes.

Lynn presented Library budget. Andy raised question of user fees for activities. We discussed request for increased staffing, some reductions in acquisitions, change in policy on late fines. We asked for information on how many library card holders are current Easton residents.

Justin presented P&Z budget. We discussed increase in Justin's hours and consulting budget, and raised the question of whether Justin should be a Consultant or Employee. Dave is not confident that a change is appropriate, and we are still undergoing some transition, but he agrees the question can be explored over the next year. We discussed FY24 capital projects (Gateway Sign, and Planting Project at South Park Detention Basin). We discussed potential 5-year future capital project plans.
