- Robert Lessler moved to approve the minutes of the Board of Selectmen Meeting, July 18, 2019. Kristi Sogofsky seconded. Motion passed unanimously.

- Kristi Sogofsky moved to approve the adoption of the RESOLUTION WITH THE STATE OF CONNECTICUT DEPARTMENT OF EMERGENCY SERVICES AND PUBLIC PROTECTION, DIVISION OF EMERGENCY MANAGEMENT AND HOMELAND SECURITY. (see attached) Robert Lessler seconded. Motion passed unanimously.
