- 9. Robert Lessler commented that the road commission is to be made up of three civil engineers and that the Ordinance probably needs to be revisited. David Bindelglass thanked Matthew Gachi for his service to the town as chairman of the Board of Finance. He would also like to thank Maple Row Tree Farm for the donation of the Christmas Tree at Town Hall and the Easton Garden Club for the donations of the wreaths and garland that were placed on town buildings.
