- 2. A resident asked the Board of Selectmen for clarification as to why P&Z is requesting that functional apartments be dismantled. Several residents shared how insulting and disingenuous it is to allow a senior housing presentation to happen during today's meeting after the legislative body voted for a conservation easement on May 31, 2022.
- 3. Robert Lessler moved to approve Driveway Bond Release, PERMIT #1128, 18 The Circle, to Outdoor Lawn Services, LLC in the amount of \$750.00 as recommended by Ed Nagy, Director of Public Works. Kristi Sogofsky seconded. Motion passed unanimously.
- 4. Kristi Sogofsky moved to award the bid to MHQ, Inc for (1) 2022 Ford Police Interceptor Utility in the amount of \$34,612.10 as recommended by Richard Doyle, Chief of Easton Police Department. Robert Lessler seconded. Motion passed unanimously.
- 5. Robert Lessler moved to appoint Berchem Moses in the interest of the town on any and all assessment appeal actions for this year with respect to the 2021 reevaluation. Kristi Sogofsky seconded. Motion passed unanimously.
- 6. David Bindelglass moved to appoint Amy Wolfcale to the Agricultural Commission as a member for term ending 1/2/25. Robert Lessler seconded. Motion passed unanimously. Robert Lessler moved to appoint Nanette DeWester from alternate to member to the Commission for the Aging term ending 1/2/23. Kristi Sogofsky seconded. Motion passed unanimously. Kristi Sogofsky moved to appoint Elizabeth Boyce as alternate to the Library Board of Trustees term ending 1/2/24. Robert Lessler seconded. Motion passed unanimously.

Kristi mentioned that she was surprised to see this presentation on the agenda since the town voted for a conservation easement and the Board of Selectmen are currently working on the documentation. She feels this is late in the game and a moot point. David is allowing the presentation because a resident did not feel safe to present during the special town meeting. David stressed that this is only a presentation no action will be taken. Raymond Rizio presented the proposal for Land Sail Properties LLC for a senior housing development at 18-22 South Park Ave.
- 8. Several residents shared their opposition with having to listen to this presentation when the town process was followed and a vote for a conservation easement was already set.
- 9. No Board member comment. David said he would speak to the P&Z commission regarding the apartments.
