MEETING MINUTES
Easton Board of Selectmen
May 18, 2017 – 7:30 p.m.
Town Hall Conference Room A

Adam Dunsby called the meeting to order at 7:30 p.m. Present: Adam Dunsby and Robert Lessler

- Robert Lessler moved to approve the minutes of the Easton Board of Selectmen Meeting of May 4, 2017.
 Adam Dunsby seconded. Motion passed unanimously.
- 2. No public comment.
- Robert Lessler moved to award the bid for Medium Duty Dump Truck as recommended by Ed Nagy, Director of Public Works to Hine Bros. in the amount of \$171,420.07. Adam Dunsby seconded. Motion passed unanimously.
- 4. Robert Lessler moved to appoint Berchem, Moses & Devlin, P.C. legal counsel for Duque vs Town of Easton. Adam Dunsby seconded. Motion passed unanimously.
- 5. Robert Lessler moved to appoint Berchem, Moses & Devlin, P.C. legal counsel for Edupuganti vs Town of Easton. Adam Dunsby seconded. Motion passed unanimously.
- 6. Robert Lessler moved to approve the AFSCME Local 1303 agreement as set forth in the summary presented covering the period of July 1, 2017 through June 30, 2021. Adam Dunsby seconded. Motion passed unanimously.
- 7. With the recommended 5% cost share of the new Connecticut 2.0 Health Plan, each of the categories: Employee, Employee +1 and Family will see a savings. Robert Lessler spoke of his firsthand experience with using the Connecticut 2.0 Plan. There are requirements for routine checkups however the coverage provides for these with the thought process of routine care improves overall health and prevents illness that may go undetected. Co-pays are minimal and there is a 96% doctor match to the current HSA Plan. Robert Lessler moved to change the non-union Employee Health Plan to the Connecticut Partnership 2.0 Plan for a period of one year commencing on July 1, 2017 with a 5% employee premium share. Adam Dunsby seconded. Motion passed unanimously. (This change replaces the previously voted on motion of January 19, 2017 adjusting the non-union employee contributions/ Rx coverages for the upcoming year.)
- 8. Adam Dunsby mentioned that the Connecticut Siting Council will be here June 20, 2017 at the Library Community Room for a hearing on the proposed cell tower. At 7:00 p.m. the public comment session will begin.
- 9. Robert Lessler moved to adjourn at 8:02 p.m. Adam Dunsby seconded. Motion passed unanimously.
