Meeting Minutes TOWN OF EASTON, CONNECTICUT Commission for the Aging Special Meeting Easton Senior Center Tuesday, September 6, 2016

a. MCS Fund

Status is same on the MCS fund. Newly appointed Finance Director, Christine Calvert, is currently reviewing the fiduciary processes of the Town and will revert with more information to the CFA concerning the Fund.

a. One Difficult MA cases

Alison provided an update on a senior welfare case which occurred during the summer months. The CFA gave feedback and discussed the nature of this case in conjunction with general senior problems of health and communication in tandem with caregivers and legal issues. Alison would like to address general topics of interest that can render proactive steps and educate seniors.

b. Cell Tower

The MA office is concerned that appropriate and timely outreach in emergency situations cannot be achieved if there is no communication, especially in lower Easton area where currently there is no cell tower. The CFA discussed the problem of cellular coverage. Joel will contact the First Selectman to inquire the status of the cell towers vis-à-vis the various cell carriers' interest to actually build the tower in area south of SSES.

c. Program Suggestions by Mary Pajonas Ideas for proposed presentations and workshops were presented by Mary and discussed by the CFA members. Alison will review for possible set up.
