Anne Hughes brought a State of Connecticut Official Citation to present to Easton Centenarian Arlene Wilson.

Anne spoke about issues from the State Assembly where advocates and industry officials are speaking on a bill to boost transparency in nursing home operations, lawmakers unveiled another sweeping measure that would overhaul numerous key aspects of the elder care sector, including requiring more oversight of home care workers, creating a speedier process for accessing Medicaid and expanding the long-term care ombudsman's office. <u>C G A - Connecticut General Assembly</u>
