She also attended the Connecticut Conference of Municipalities (CCM) with Christine Halloran, Easton Town Clerk. The conference topic reviewed organizational matters regarding record keeping, retention of files, and destruction. Alison attended her first Greater Bridgeport Elderly Services Counsel meeting and made some connections in the

Phyllis has suggested to SWCAA that a communication link be established for local Municipal Agents to share ideas and issues.
