Meeting Minutes TOWN OF EASTON, CONNECTICUT Commission for the Aging Special Meeting Easton Senior Center Tuesday, December 1, 2015

- a. Update on Jesse Lee Turkey Dinner deliveries Alison Witherbee picked up the individual dinners which were ready at 6PM and delivered 17 meals to the various homebound or frail seniors. Everyone was thrilled and appreciative for the outreach prior to the Thanksgiving holiday.

"Senior Guide" Proposal Alison Witherbee provided information to the CFA members on a booklet prepared by Redding, CT which lists pertinent contact information of organizations and other key venues specifically for the senior population. She and Joel Peskay will review the material listing for a possible template. CFA members will follow up with further discussion at next meeting.
- c. Municipal Agent's Report Alison Witherbee had a busy November with another session for the Medicare Open Enrollment and providing assistance with fuel assistance applications. She also delivered the Jesse Lee Turkey dinners. Through the Easton Garden Club, poinsettias will be delivered to 10 homebound seniors. Alison is following up with creation of a list of seniors who have attended various presentations and is tackling an idea for a senior guide booklet. She has asked the local clergy that she or Pam Healy can be contacted directly if there is a need by a senior.
