Meeting Minutes Commission for the Aging Town of Easton, CT

Monthly Meeting – special, Monday, February 8, 2021 – 5:00 PM to 6:00 PM Held at the Easton Senior Center

Update on Coronavirus Vaccine

Currently Connecticut residents age 75 or older are eligible to sign up and receive the COVID-19 Vaccine. Beginning on February 11th, Connecticut residents age 65 and older will be eligible to sign up. Each individual needs to sign up at the VAMS (vaccine administration management system) https://dphsubmissions.ct.gov/OnlineVaccine which is an online enrollment system. Each individual will then receive an email from CDC.GOV/VAMS which will allow them to make an appointment to receive the vaccine at numerous locations or if they wish reach out to the Easton Senior Center for assistance of call the CT COVID Vaccine Appointment Assist Line directly 877-918-2224.

Southwestern CT Agency on CT provides funding for community and home based projects for adults aged 60 and older under Title III of the older Americans Act through an annual Request for Proposals.

Alison is looking to apply for some mini grants that will enable an array of services to meet needs for those Easton residents in the specific segment. The types of services for which funding is available include: Community-based and in-home supportive social services (Title III-B); Evidence-based health promotion services (Title III-D); Family caregiver support services, grandparents raising grandchildren (Title III-E); and Congregate and home-delivered meals, nutrition education and counseling (Title III-C). Priority is given to programs that assist economically and socially disadvantaged older adults. Public, incorporated non-profit or private for-profit agencies serving seniors within SWCAA's fourteen-town area are eligible to apply

The members in attendance support the idea to apply for grants. This topic will be discussed and acted upon more at length at the next meeting.
