1. The minutes of the Tuesday, April 5th March special meeting were reviewed and unanimously approved on a motion by Margaret Silvestri and seconded by Joel Peskay.

2. Unfinished Business

 a. MCS Fund

- a. Update on "Healing the Heart" Group
 The program has been successful as it is addressing and providing support,
 therapy and education. It is a rewarding and invaluable experience for the
 attendees and co-leader, Marguerite McVay, has been a great asset. Alison is
 planning to offer another session in Fall 2016.
- b. Programs for May 2016 Alison has scheduled the following events for May: 1/ Senior Medicare Patrol Presentation on May 10th and 2/ Medicare Savings Program Presentation on May 19th. Both events are presented by SWCCA personnel. 3/Living Wills & Advanced Directives on May 11th. This topic will be facilitated by Attorney Sharon Cregeen and attendees will learn what type of documentation is required; it then will be continued, 4/ On May 25th there will be a one on one discussion and follow through of paperwork with Sharon Cregeen. - c. Municipal Agent's Report Alison Witherbee recently attended a meeting in Groton, CT hosted by CAMAE (CT Association of Municipal Agents for the Elderly). Breakout sessions reviewed the roles of M.A. and interaction in communities. Another

conference hosted by CAPE (Coalition for Abuse Prevention of the Elderly) highlighted raising awareness about elder abuse and education/training to teach about signs/symptoms of abuse, reporting requirements and available intervention resources. Alison is planning another "Healing the Hearts" group for Fall 2016 and re-visiting the "Seniors Driving Safely" topic to provide additional tips and information. Alison has senior events planned for the month of May to address Medicare fraud protection and Advanced Directives and she will then attend training for a program launched by the Veteran's Affairs.

d. SCWAA Report
