MINUTES FOR THE TOWN OF EASTON CONSERVATION COMMISSION EASTON TOWN HALL CONFERENCE ROOM A

Tuesday September 25, 2018 7:30 p.m.

PRESENT: Dori Wollen, Chair; Catherine Alfandre, Steve Corti, Steve Hume, Elliot Leonard, **ABSENT:** Vivian Hardison, Sarah Cwikla, Steven Montgomery

- 1. Chair Dori Wollen called meeting to order at 7:35 p.m. Minutes were recorded by Cathy Alfandre
- 2. INLAND/WETLAND APPLICATIONS: *I/W* #18-539 691 Morehouse Road Easton Public Library Add addition where current patio is located received 7/18/18 + 65 days = 9/21/18. On September 18, 2018 an extension was granted and accepted for 65 days until 11/25/18, which is the maximum. Marco Constantini presented a revised plan that omitted the proposed walkways around the building. The new plan encloses the existing patio and into half of the current walkway in front of the patio. Steve Hume moved and Cathy Alfandre seconded to approve permit #18-539 with the following conditions:
 - 1. Standard stipulations;
 - 2. Permanently removing the shed, the police car and the trailer on the parking lot,
 - 3. Also permanently moving the trash bin to the other side of the property to the concrete pad;
 - 4. Repair and replace the wooden fence;
 - 5. Construction material to be placed west of the building marked as "staging area" on the map dated 9/17/18;
 - 6. The well is to be delineated by 4 caution stakes with orange caution fencing. The motion was approved by unanimous voice vote.
 - L/W #18-542-537 as amended: North Street-Kevin Wade and his attorney, John Lambert, were present. Final plans including construction sequence and monitoring plans dated 9/21/18 were presented for consideration. Upon extensive discussion, the following changes were made on the plan and initialed by Mr. Wade:
 - a). the slope of the ponds is to be 4:1 all around (2:1 was crossed out);
 - b). the pipe on the driveway is to be replaced as well as marked and initialed (this is in addition to the pipe already marked on the map)
 - c). underground utilities to be installed west side of the driveway;
 - d). install boulders to delineate the wetlands/regulated areas as shown on the map dated 9/21/18-9/25/18.

Upon further discussion, Steve Corti and Steve Hume seconded to approve application #18-537 as amended with the following stipulations:

- 1. Driveway to be regraded and stabilized prior to and after any construction;
- 2. Underground utilities to be placed on the west side of the driveway and must be shown on an as-built plan;

- 3. The two pipes as shown on the map must be replaced in their entirety;
- 4. Underground utilities going down west of the driveway should turn east crossing over by the replaced pipes.
- 5. The areas around the ponds are to be planted with indigenous trees, shrubs and marsh plants as noted in Mr. McManus' report of Sept. 9, 2018 and noted on the map of 9/21/18-9/25/18;
- 6. The spillway is to be located where the outlet is currently discharging;
- 7. Additional trees can be cut down only between 20 feet south of the dewatering area and 4 feet south of the spillway as shown on the map.
- 8. Any cutting of trees in the regulated area or on the west side of the pond to the border will need another permit from this Commission;
- 9. The sequence of construction as noted on the map last revised 9/21/18 must be adhered to, including expected timetable and monitoring the construction;
- 10. Standard stipulations;
- 11. Approval is subject to withdrawal of the appeal filed by Mr. Wade on August 17, 2018.

Motion was approved by unanimous voice vote.
