## 225 Center Road - Easton, Connecticut 06612 MINUTES FOR THE TOWN OF EASTON CONSERVATION COMMISSION EASTON TOWN HALL CONFERENCE ROOM A November 12th, 2019 7:30 p.m.

PRESENT: Dori Wollen, Chair, Cathy Alfandre, Vivian Hardison, Elliot Leonard.

Chair Dori Wollen called the meeting called to order at 7:32 p.m.

- 1.) #19-559- received 8/27/2019 + 65 days = 10/31/2019- Lot 6 Tatetuck Trail Nagy Enterprises, Inc.- Construct new house and driveway. Norman Nagy and Donna Nagy-Burzynski appeared on behalf of this application. Chair Wollen stated that it was her understanding that the applicants has requested that P&Z address the easement. Mr. Nagy related the history of the trail that became the easement and described the very large trees that line one side of it. There was an extensive discussion of the driveway as currently built and the trail along the pedestrian easement. The commissioners agreed that they would need to revisit the site before any decision can be made.
- 2.) #19-562- received 10/22/2019 + 65 days = 12/26/2019- 64 Sport Hill Parkway, Jeanine Scotti Septic System repair. Danny Epifano of J. Epifano & Son, Inc. appeared on behalf of Ms. Scotti. Cathy Alfandre moved to approve the replacement tank with standard stipulations and the installation of a silt fence around the area of disturbance. Elliot Leonard seconded.

**VOTE**: Application # 19-562 was approved by unanimous voice vote.

lack of funding in DEEP for dam oversight. She read the letter she had sent to DEEP about Mr. Toscano and Big Lake Dam.

The secretary presented the proposed 2020 meeting calendar. The Commission told her to publish it.

Chair Wollen read a letter from Attorney Fallon regarding the After the Fact application requested of Mountain Grove Cemetery for their recent drainage work. He asked to be allowed to appear before the Commission at their meeting of December 10<sup>th</sup>, to present the application and map.

Chair Wollen advised she had received a request from DPW and the First Selectman to extend the permit for application #17-531 South Park Avenue Bridge #04231 bridge repair. Cathy Alfandre moved to add this item to the agenda under new business. Elliot Leonard seconded the motion. **VOTE**: The motion to amend the agenda for November 12<sup>th</sup>, 2019 by adding the Town's request for an extension was approved by unanimous voice vote.

Vivian Hardison moved to extend permit # 17-531 South Park Avenue Bridge #04321 bridge repair for a period of 2 (two) years until November 27<sup>th</sup>, 2021. Cathy Alfandre seconded the motion. **VOTE:** the motion to **extend permit #17-531 until November 28<sup>th</sup>**, 2021 was approved by unanimous voice vote.
