## MINUTES FOR THE TOWN OF EASTON CONSERVATION COMMISSION REGULAR MEETING CONFERENCE ROOM "A" TOWN HALL July 28, 2021, 7:30 p.m.

Chair Dori Wollen called the meeting to order at 7:30. Karin Niesyn was administered the Oath of Office by the Town Clerk on July 14, 2021.

They were questioned regarding where spoils from excavation from the pool would be stored until trucked away. Mrs. Blonstein said the plan was to remove the material immediately, but that it could be placed next to their driveway in the front of the house. Several Commissioners had difficulty in determining where the wetlands limit was shown on the site plan. Mrs. Blonstein took a site plan to measure and will return it to the office.
