MINUTES FOR THE TOWN OF EASTON CONSERVATION COMMISSION REGULAR MEETING October 26, 2021 7:30 p.m.

PRESENT: Dori Wollen, Chair, Cathy Alfandre, Vivian Hardison, Elliot Leonard, Steve Montgomery, Karin Niesyn.

ABSENT: Sarah Cwikla, Maria Corti.

Public present: Mark Ochman, Jimmy Wright, Magda Fuentes, plus another person, David Chen, Harold Rosnick.

Chair Dori Wollen called the meeting called to order at 7:32 p.m.

Karin Niesyn appointed to vote for Sarah Cwikla.

- 1.) #21-601- Received October 26th, 2021+ 65 days =12/30/2021-8 Canterbury Lane, Fuentes, Magda, Construct inground pool, remove weeds and dead trees. Magda Fuentes appeared on behalf of this application. She stated that there are a number of trees on her property which are dead or declining, and that there is an area near a watercourse which is overgrown with weeds. She wants to clear out the weeds and plant a butterfly garden. She stated she would have a professional arborist mark trees which are dead or dying. Chair Wollen asked to have her architect to clarify the lines on the site plan because the terminology is unclear. Ms. Fuentes was asked to have the 100-foot line marking the upland review staked as well as marking all trees which are to be removed.
- 2.) #21-602-Received October 26th, 2021 + 65 Days = 12/30/2021. 433 Center Road, Alain Bourgeois. Construct 1 story house, detached garage, accessory structure, replacing current structures. Mark Ochman appeared on behalf of this application. He stated that the proposed house will be no closer to the wetlands than the current house. It is planned to have a grassy "lane" outlined by stone walls to provide access to the rear of the property. Mr. Ochman said that the accessory structure which is to be rebuilt is outside the upland review area. Chair Wollen asked to have the property staked.
- 3.) #21-600 -41 Adirondack Trail, Ong Lee-Received October 26th, 2021 + 65 days= 12/30/2021. Chair Wollen stated that research of Commission files showed that an application for this address should be accepted for review. David Chen appeared on behalf of the application. A review of his site plan showed that the majority of the site is outside the upland review area. The only area that falls within the upland review area is a small portion of the proposed driveway. Several Commissioners stated that Mr. Chen could proceed to have the rest of the lot cleared. Chair Wollen asked to have the driveway and the wetlands line staked.

- Mr. Chen was advised that since the proposed structures are not within the review area the fee will not be for a new residence, but for a wetland crossing.
