# MINUTES FOR THE TOWN OF EASTON CONSERVATION COMMISSION REGULAR MEETING – EASTON TOWN HALL CONFERENCE ROOM A TUESDAY September 27, 2016

1. Meeting called to order at 7:32 p.m.

### INLAND/WETLAND APPLICATIONS:

A. Maplewood Farm @ Easton, LLC - 20 & 70 Wilson Road - expanding existing pond needed for watering. Received 9/27/2016 + 65 = 12/1/2016. The applicant Robert Smith and his attorney Arthur Miller presented the proposed expansion of a pond. He plans on using the land for farming and would like to use the pond as a water source; he indicated all stone walls will stay in place and the pond will be fenced in. It was discussed by the commission and determined he is within his "As of Right" and approval was given. The commission requests that when the project is completed an "As-built" survey be submitted.

Mr. Maquat had revised the request for "As of Right" determination to continue the farm access road. He provided a plan which was reviewed by the members and discussed. Continuation of the approved "As of Right" determination was granted.
