  - d. Expansion/Building Committee: There is a question if the current Committee should be dissolved and re-formed when the project moves forward.
- 8. New Business:
  - a. Board Self-evaluation: A patron suggested that the Board should do a self-evaluation at least annually. Lynn will look for a template to present at the next meeting.
