- 1. Meeting was called to order at 7:06pm.
- 2. Minutes from March: Meeting minutes were approved with a motion by Adrienne and seconded by Linda.
- 3. Treasurer's Report: The money that was transferred to Vanguard placed into a short term treasury fund.
- 4. Library Director's Report: Please see attached. In addition, it was noted that the Friends of the Library meets on the fourth Wednesday of the month from 7-8. Starting tonight, the library will be open until 6 on Mondays, Tuesday and Wednesday, pre-covid hours.
- 5. Friends of the Library Report: Fundraising events and opportunities were discussed.
- 6. Bills and Communication: Bills that came in last month were paid. No other communication received this week.

- 8. Old Business:

EASTON PUBLIC LIBRARY BOARD OF TRUSTEES REGULAR MEETING – April 5, 2021 LIBRARY DIRECTOR'S REPORT

- 1. Our new Library sign was hung and unveiled on March 30. It looks great! Mike Ogrinz and his family have generously decided to donate it to the Library.
- 2. Bob Knapik has replaced Kevin Krug as a Library Assistant Circulation & Information. He started on March 29 and is working out well.
- 3. The Library's callback with the Board of Finance took place on March 31. We had to give back \$3,775 of the increases we had requested \$2000 for Programming, \$175 for ALA Membership, and \$1,600 for Digital Resources. The furloughed position will remain on furlough for the upcoming budget year.
- 4. In a conversation with Dave Bindelglass, it was decided that we would open up the meeting rooms again, effective April 1. Community Room capacity is 25 and Conference Room capacity is 6.
- 5. The Friends of the Library has appointed Renee Neiger as the liaison to the Library Board. She will attend Board meetings going forward.
