## **BOS Subcommittee for Park & Rec Dept Review**

Commission reviews recommendations.

1) Vacation Time and Overtime - Put a policy in place so the Supervisor and Maintainer cannot take vacation at the same time. Also that overtime has to be approved by the Director.

Phil Tamallanca makes a motion that the two maintainers (Supervisor & Maintainer 1) cannot plan or take vacations at the same time. Along with overtime must be approved by the Director of the department.

- 2) Dialogue with other groups within Easton to prevent duplicate programs Director of the department should reach out to other groups to find out what programs they are running. Phil Tamallanca tabled this till the next meeting.
- 3) Board of Finance to provide oversight for Field Use account Phil Tamallanca states we can present it quarterly to the BOF. Danielle Alves feels that we can present it semi-annually. Robert Klem states that without the field use account many of the fields would not be taken care of on the department operating budget alone.

Robert Klem makes a motion that the wording should state that the BOF should provide oversight of the Field Use Account fund expenditures and review purchase practices twice a year.

Robert Klem makes a motion that the maintenance staff makes itself available to other departments to help with odd jobs and projects, must be requested through the Park and Rec Director as time permits. AJ Martinich second

5) Unplanned Outsourcing Plan - Robert Klem discusses. Phil Tamallanca discusses. Danielle Alves states that we should have a policy on the website so that companies can submit their info, insurance, and pricing so we can access that info easily and efficiently. Also a conversation with the Director and the Maintenance staff would have to be had per outsourcing issue.

Robert Klem makes a motion for the Park and Rec commission should continue to develop an outsourcing plan.

6) Snow Removal - The recommendation states; The BOS should give the maintenance staff responsibility for snow removal for 660 Morehouse for 2017/2018. The BOS may review and revisit possibly adding Helen Keller Middle School for the 2018/2019 year going forward. During a snow event, the maintenance staff should operate in coordination with the Director of Public Works (DPW) and any over-time will be monitored and charged to DPW. Phil Tamallanca and Robert Klem discuss. Mike Clark discusses. Phil Tamallanca discusses that he is concerned if there is a delayed opening or if there is a large storm.

AJ Martinich, makes a motion to have the recommendation state; The BOS should give the maintenance staff responsibility for snow removal for 660 Morehouse for 2017/2018. The BOS and Park & Recreation commission may review and revisit possibly adding Helen Keller Middle School for the 2018/2019 year going forward. During a snow event, the maintenance staff should operate in coordination with the Director of Park & Rec and the Director of Public Works (DPW) and any over-time will be charged to DPW.
