TOWN PLAN OF CONSERVATION AND DEVELOPMENT 2017:

(1) GIS mapping for Town Plan 2017 - The Land Use Director discussed the Trails Network and a possible connection from Helen Keller Middle School to Ridgedale Road cul-de-sac to Jesse Lee United Methodist Church parking lot to Flat Rock Road. This trails connection would allow great access to lower Easton on the east side of Sport Hill Road.

ITEMS FOR RECEIPT:

Application by Town of Easton for Special Permit for Flood Plain (SP-17-04). Proposed reconstruction of the South Park Avenue Bridge over Mill River. - The Land Use Director stated that the application was substantially complete to schedule for public hearing. The Commission determined that the public hearing should be set for January 8, 2018. The Chairman requested the Secretary to make sure that Representatives for the Applicant could attend that date.

TOWN PLAN OF CONSERVATION AND DEVELOPMENT 2017:

(2) Draft new text for Town Plan 2017 sections on population, public facilities, trails and greenways, a town center. The Land Use Director distributed a revision of Chapter 5, Town Development: Past Present and Future, new section, Conservation Residential, new Section, Agriculture in Easton and new Policy Proposals. The Land Use Director discussed other Sections in process, to be distributed via e-mail to the Commission. The Secretary will e-mail all Sections completed on Friday for the Commission to review over the weekend as the Commission will meet again next Monday.

The Chairman noted that he will be meeting with Town Counsel regarding the draft Zoning Regulations and the revised text for the Town Plan 2017.
