# DISCUSSION AND POSSIBLE ACTION: APPOINTMENT OF SUPERINTENDENT AND CONTRACT FOR SUPERINTENDENT

C. Parkin opened the meeting and turned it over to C. Graziano and M. Williams as the co-chairs of the Superintendent Personnel Search Committee Steering Committee. C. Graziano provided a review of the process used to search and select the proposed Superintendent of Schools. M. Williams introduced Dr. Jason McKinnon as the proposed Superintendent of Schools.

Motion: move that the Easton Board of Education, (a) in accordance with Conn. Gen. Stat. Section 10-157 appoints Dr. Jason McKinnon to serve as superintendent of schools with a start date to be mutually agreed upon, (b) that the Chair be authorized to execute the proposed contract between Dr. McKinnon and the Easton, Redding, and Region 9 Boards as joint employers, and (c) that the Personnel Search Committee's work, including the work of the steering subcommittee, be deemed completed and the committee dissolved. Chieda, Wible. Unanimous. 5-0.

Motion: move that the Redding Board of Education, (a) in accordance with Conn. Gen. Stat. Section 10-157 appoints Dr. Jason McKinnon to serve as superintendent of schools with a start date to be mutually agreed upon, (b) that the Chair be authorized to execute the proposed contract between Dr. McKinnon and the Easton, Redding, and Region 9 Boards as joint employers, and (c) that the Personnel Search Committee's work, including the work of the steering subcommittee, be deemed completed and the committee dissolved.
