### CALL TO ORDER

Mr. Johnston called the virtual Zoom meeting of the Region 9 Board of Education to order at 7:33 p.m.

## NOMINATION OF MODERATOR TO CONDUCT THE MEETING

To consider and potentially approve a funding proposal of the Region No. 9 Board of Education for the fiscal year beginning July 1, 2020 and ending June 30, 2021, in the amount of \$24,351,255.

REQUEST FOR REGION 9 2020-2021 OPERATIONAL BUDGET BE REFERRED TO THE REGION 9 BOARD OF EDUCATION MEETING ON TUESDAY, MAY 19, 2020.

Mr. Johnston presented the 2020-2021 School District Budget, approved by the Region No. 9 Board of Education, in the amount of \$24,351,255 in accordance with Section 10-51 of the Connecticut General Statutes. In accordance with Section 10-51 of the Connecticut General Statutes, the Region No. 9 Board of Education has established a Capital Reserve Fund, in which the annual appropriation shall not exceed 1% of the annual district operating budget. In accordance with Section 10-51(a) of the Connecticut General Statutes, the Region No. 9 Board of Education has a statement of Estimated Receipts and Expenditures for FY2019-20 and FY2020-21, Estimated Surplus or Deficit in operating funds at the end of the current fiscal year, Bonded Debt, Estimated Per Pupil Expenditures for the Current and the Next Fiscal Year, and the Status of the Capital Reserve Fund as of May 4, 2020.

Mr. Johnston declared that the District Meeting is to be considered adjourned to vote under CT EO7I on the Budget at the May 19, 2020 Region 9 Board of Education Regular Meeting.
