CALL TO ORDER

The Region 9 Board of Education special meeting was called to order at 7:43 p.m.

DISCUSSION AND POSSIBLE ACTION: JBHS GYMNASIUM/CAFETERIA HVAC AND SAFETY IMPROVEMENT PROJECT VENDOR EVALUATION AND DISCUSSION

M. D'Agostino gave a presentation on the ezIQC bid for the project to include scope, overview, and financials. The bid was endorsed by the Facilities & Fields Committee to advance to the Region 9 board for approval. Discussion by board members with questions and answers followed.

Motion: Move that the Region 9 Board of Education accept the Price Proposal from Millennium Construction for the Joel Barlow Gym/Cafeteria HVAC and Safety Improvement Project in the amount of \$831, 089.03 under the guidelines of the state approved ezIQC Procurement Program and instruct the Director of Finance and Operation to issue a Purchase Order by April 21, 2021, and forward a copy to the Chairman of the Facilities and Fields Committee (D'Agostino, O'Brien). Approved. Unanimous.

Motion: Move that the Region 9 Board of Education form a Building Committee for the Joel Barlow Gym/Cafeteria HVAC and Safety Improvement Project to consist of all members of the Facilities & Fields Committee and a member of the public representing the
