COMMENTS FROM DR. GARY RICHARDS REGARDING THE SUPERINTENDENT SEARCH PROCESS

He noted that the Search Steering Committee worked diligently to review the needs of the schools, the students, staff and communities. Fourteen applications were received, four were brought forward for interviews with the Search Steering Committee, and three were brought before the tri-board interviews. He thanked Vicki Cram for her assistance during the process.

Mrs. Gombos commented that the Boards of Education would miss working with Dr. Josefsberg. She commented that this was a time for celebration of a job well done by Dr. Josefsberg, and for the appointment of Dr. McMorran as the new superintendent.

Mr. Miller added that the school district is in a better place due to the work done by Dr. Josefsberg. Dr. Peskay thanked the Search Committee co-chairs, Mrs. Sobel and Mr. Hicks for their work.
