PUBLIC HEARING

ZBA-22-02, Tricia Beal, 56 Burr Street, Easton, CT. The applicant requested a Variance of the setback requirements (30.8 ft in lieu of 40 feet) under Section 3500, Area and Dimensional Standards, in the Easton Zoning Regulations. This request is to allow for the building of an attached 2 story 3-bay garage which would include a master bedroom with bath, laundry room, and additional shared bathroom for the two existing bedrooms on second floor, approx. 1,000 sq. ft. A copy of the application and corresponding documents are on file in the office of the Easton Town Clerk and on the Easton Town web-site attached to the legal notice posted by Zoning Board of Appeals.

- Tricia Beal was in attendance along with Stephen Izzo who made a presentation of the proposal and answered questions from the Acting Chairman and Board Members.
- Neighboring residents Chris & Beverly Nardone (47 Burr St) and Linda Cronin (62 Burr St). were in attendance and spoke in support of applicants' request.
- Board Member Charmoy asked for clarification on location of addition and applicant Izzo
 explained it is a very narrow lot therefore to move the location would not be feasible.
