I. Call to Order: Meeting called to order at 7:35 p.m. by Jean Stetz-Puchalski

III. Reports:

- Morehouse Civic Park Plan: Active farming project of plots A & B not currently defined on plan. Made recommendation to John Hayes to include this active project on the plan. Follow up meeting with John Hayes and communication with John Broadbin to help clear up the omission. The Farmer who holds lease with town was concerned at the lack of mention and worried that the fields would be compromised.
- Jean called for an Ag commission representative to be responsible scanning the town committees and commission agendas for ag related topics and issues. Laurel Fedor accepted the position and will be point person to monitor town website for ag related issues and report back so we may plan to have ag com representation at meetings as needed.
- Jean to meet with Sport Hill Farm to help facilitate communication with the Board of Education and the principal Kim Fox regarding the educational component of the farming project on town land.
- CT General Statutes update for P&Z: Requested to be placed one 9/22 agenda for planning meeting to provide update on planning for ag.

GIS mapping of ag rich soils: Is this still a priority for Easton. Will confer with Town Planner, John Hayes.

Alternate for commission: Allison Taylor will submit a letter of interest to Board of Selectmen to be considered for position. Will encourage other applicants as well.

Signage: Popp's received violation from town for their new sign. Passed on application for them to fill out and submit. New digital signs for Silverman's traffic. Commission will promote ag friendly town policy for tasteful signage
