CALL TO ORDER

R. Hicks called the Easton Board of Education Regular meeting to order at 7:02pm.

CONSENT AGENDA

ADMINISTRATIVE REPORTS

Ms. Fox Santora provided an update about Samuel Staples Elementary School. She discussed the donation (Green Grant) from ELF for \$6,000, Teacher Appreciation Week, Invention Convention finalists, and Nature's Classroom. She also provided an update on Kindergarten enrollment (92 packets picked up).

Dr. Clapp provided an update about Helen Keller Middle School. The middle school also has a new garden. He also provided an update on Teacher Appreciation Week and let the Board know that the report included many end of year events.

Dr. McKinnon provided an update on the Special Education Focus Groups. He explained that he's using that information and other data to come up with a strategic plan focused on special education. It will be broken down into four domains and be developed between now and the June meeting. Then at the June

meeting he will share the concepts and get some input. He also thanked teachers and staff as well as the PTO and leaders for their dedication to our students.
