Call to Order: By Chair Art Laske at 8:03 pm

Motion to appoint alternate Mike G in place of Jackie until Jackie arrives, by Mike K/Andy. Result: passes 5-0. Jackie arrives 8:04.

- (Agenda item #1) Discuss and approve the meeting minutes of April 4, 2023.
 Ira notes item #7 paragraph 1 refers to Reductions to 5128 PT non-union. It should read 5119 PT non-union instead. Motion to approve minutes as amended, by Paul/Mike K. Result: passes 6-0.
- 2. Discuss and act upon Tax Collector's Suspense List. (8:05) Krista explains her process. Andy expresses concern that people be given due warning before a collection agency gets involved and asks about effect on credit rating of individuals. Mike Kot explains that he collects money from deadbeats, and the longer you wait to collect, the less success you have. The parameters of who is affected are detailed. Motion to move submitted outstanding tax collection items to the Tax Collector's Suspense List, representing \$44,311.84, by Andy/Paul. Result: passes 6-0.
- Discuss and possible action regarding the DPW capital account. (8:21)
 Ed explained the seasonal nature of project work and the need to transfer funds. <u>Motion</u> to transfer \$196,330 from the FY23 Road Paving and Reconstruction Capital Project Fund to the FY24 Road Paving and Reconstruction Capital Project Fund (line 04244350-5035), by Paul/Jackie. Result: passes 6-0.
- Treasurer's Report (8:24)
 Chris referred to new handout. We discussed M&T Bank, Janney, and CT STIF, and possible fund movement for higher rates.
- Discuss and possible action on Munis Financial Report for appropriations and revenue presented by the Finance Director. (8:25)
 Chris comments on costs for senior center van, costs at 660 Morehouse Road, etc. Gregg asks about the

Undesignated Fund Balance (UFB) and how much money will be returned to increase the UFB. Chris says last year roughly \$1,500,000 was returned, and she estimates this year we will get \$1,000,000 or more returned.

- Chris and Art report news that the voters passed all three measures on the referendum today, and that Redding has passed their Region 9 budget as well.
- 6. Discussion and possible action on 2023/2024 budget machine vote, and if applicable, set mill rate, or begin budget adjustments, decide upon tax collection procedures, and any other action deemed necessary for the 2023/2024 fiscal budget year. (8:36)
 Chris says the 6/30/22 UFB was \$7,109,429 and her estimate is that the 6/30/23 UFB will be approximately \$2,500,000 higher, at about \$9,609,429. Andy expresses the desire to return surplus to taxpayers but weighs that against upcoming costs for an EMS building and a new roof for Helen Keller Middle School, along with other costs. He notes that whether ARPA funds are used for EMS or HKMS, a big funding gap will remain, and that borrowing money would be expensive. Andy recommends allocating \$2,950,000 from the UFB, the same amount that was designated one year ago. Art advocates a middle ground to avoid volatile changes. Ira agrees with Andy. Mike K recommends \$3,000,000 instead, and Jackie is fine with either number, as is Ira. Paul advocates for a lower UFB and usage of \$3,775,000 to keep the mill rate flat. Motion to set mill rate at 28.96, reflecting appropriation of \$3,000,000 from the UFB towards the FY24 budget, by Ira/Mike K. Result: passes 5-1 (Paul voting no).
- 7. Motion to adjourn by Mike K/Paul. Result: passes 6-0 at 9:01.
