I. PRELIMINARY BUSINESS

- A. Correspondence: Loretta Harsche notified the department of her retirement. A reception is being held in her honor on March 16. PO Ceccarelli has been cleared to return to active duty.

II. PUBLIC COMMENT

V. NEW BUSINESS

- B. A motion was made by Commissioner Gelfand to approve the Minutes for the Special Meeting of March 3, 2016. Vice Chairman Israel seconded the motion and the motion passed unanimously.


- C. The Commission discussed the 2016 MS Bike Tour scheduled for June 12. No action was taken.
- D. Representatives from United Illuminating discussed the cost of traffic control in Easton in terms of the cost per hour for cars and officers compared to other towns, as well as the cost of cars and officers as a percentage of the total cost for tree work. Since the cost of doing work was claimed to be higher in Easton than in other towns, UI suggested that this may influence the priority placed on performing future tree work in Easton. No action was taken.

- A. A motion was not made to go into Executive Session.

Chairman Colangelo called for a motion to adjourn the meeting at 6:17 pm. Said motion was made by Commissioner Gelfand, and the motion was seconded by Chairman Colangelo. The motion passed unanimously.
