The Easton Police Commission Meeting was called to order at 5:30 pm by Chairman Colangelo.

I. PRELIMINARY BUSINESS

- A. Correspondence: A memo to Chief Shaw from PO Kinahan dated June 13, 2016 provides an update on the status of communications between the EPD and the CT DOT. The memo concerns placement of a stop sign and stop bar at the intersection of Redding Road and Route 136.

II. PUBLIC COMMENT

- A. Rick and Janie Muir expressed concerns over cars parking in their neighborhood during blueberry picking season. A motion was made by Chairman Colangelo and seconded by Commissioner Herrmann to add agenda item V. C. Discuss and take possible action on the placement of temporary No Parking signs. - A. A motion was made by Commissioner Gelfand to approve the Minutes for the Regular Meeting of June 13, 2016. Vice Chairman Israel seconded the motion and the motion passed unanimously.
- B. A motion was made by Chairman Colangelo to approve a Road Permit for the 2016 Dream Ride as outlined in an email from organizer Pete Marcucio dated June 29, 2016. Commissioner Herrmann seconded the motion and it passed unanimously.
- C. A motion was made by Chairman Colangelo to approve the placement of temporary no parking signs during the blueberry picking season in the area of Freeborn and Norton Road. Commissioner Herrmann seconded the motion and it passed unanimously.


VI. EXECUTIVE SESSION
