III. CHIEF'S MONTHLY ACTIVITY REPORT

The May and June Incident Analysis reports were reviewed. During the month of May there were three (3) delayed responses: none (0) on the first shift, two (2) on the second shift, and one (1) on the third shift. During the month of June there were seven (7) delayed responses: none (0) on the first shift, two (2) on the second shift, and five (5) on the third shift.

PO Tibbals was commended by a resident for his work in recovering a stolen vehicle.

Firearms training has been rescheduled from July to August, to accommodate certain neighbors.

IV. NEW BUSINESS

- A. A motion was made by Commissioner Herrmann to approve the Amended Minutes for the Special Meeting of May 11, 2020. Said Amended Minutes indicate Detective Lyman was recognized for ten years of service in April, not March. Chairman Colangelo seconded the motion and the motion passed unanimously.
- B. A motion was made by Chairman Colangelo to approve a road use permit for the 2020 "Freedom Isn't Free" Motorcycle Ride as recommended by PO Kinahan. Commissioner Battaglia seconded the motion and the motion passed unanimously.
- C. A motion was made by Commissioner Herrmann to approve a road use permit for the 2020 Dream Ride as recommended by PO Kinahan. Commissioner Smith seconded the motion and the motion passed unanimously.

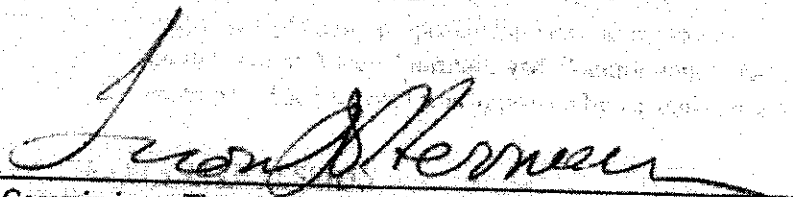
- D. A motion was made by Chairman Colangelo to approve a "No Outlet" sign at the intersection of Wedgewood Drive and Bartling Drive as recommended by PO Kinahan. Commissioner Smith seconded the motion and the motion passed unanimously. A motion was made by Commissioner Herrmann to approve "Blind Pedestrian" signs north and south of 163 Judd Road as recommended by PO Kinahan. Chairman Colangelo seconded the motion and the motion passed unanimously.
- E. A motion was made by Chairman Colangelo to approve a vacation carryover request by Chief Doyle. Commissioner Herrmann seconded the motion and the motion passed unanimously.
- F. Chairman Colangelo proposed that he continue to serve as Chairman, Commissioner Smith serve as Vice Chairman, and Commissioner Herrmann continue to serve as Secretary. The proposal was approved by general consent.
