## III. Chief's Monthly Activity Report

- a. The May Incident Analysis was reviewed noting 5 delayed responses.
- b. A verbal report was provided on new pistol permit applications.
- c. On 5/27, the bid for a new car was completed and a recommendation was sent to the selectmen.

- b. Chairman Colangelo made a motion to approve the permit for the 2022 Dream Ride, Commissioner Alfandre seconded. Motion passed unanimously.
- c. Dennis Pryor gave a short presentation requesting a stop sign at N. Park Ave and Church Rd. Chief Doyle proposed a survey of the intersection to determine a course of action.
- d. Commissioner Alfandre made a motion to approve EVFD request to close Center Rd for their annual carnival. Chairman Colangelo seconded. Motion passed unanimously.
- e. Chairman Colangelo made a motion to approve the implementation of the T2 Center Speed Display Sign Program. Commissioner Battaglia seconded. Motion passed unanimously.
- f. Gary Ceraso presented his concerns with the Tow Operators Procedures Policy. Chairman Colangelo made a motion to authorize the Chief and Sgt. Ceccorelli to revise the tow policy pursuant to the needs of our town and department. When the policy is redone, we will set it to a vote via email to expedite the approval process. Commissioner Alfandre seconded. Motion passed unanimously. Chairman Colangelo made a motion to delay our tow list approval to the July meeting. Commissioner Battaglia seconded. Motion passed unanimously.
- g. Chairman Colangelo made a motion to approve the E-Citation Grant to allow EPD to get reimbursement for hardware costs and authorize the expenditure of \$25,778.00 to cover the software costs. Commissioner Alfandre seconded. Motion passed unanimously.
