- 1. Kristi Sogofsky moved to approve the minutes of the Board of Selectmen Meeting, March 4, 2021, as amended. Robert Lessler seconded. Motion passed unanimously.
- 2. No Public comment.
- 3. Robert Lessler moved to approve the following tax refunds as recommended by Krista Kot, Tax Collector: 1. CORELOGIC - \$7,993.66; 2. CORELOGIC - \$4,211.04; 3.CORELOGIC - \$6,339.81; 4.
