Easton Board of Selectmen Meeting June 4, 2015 – 7:30 p.m. Town Hall Conference Room A

Present: Adam Dunsby, Scott Centrella, Robert H. Lessler

The First Selectman convened the meeting at 7:30 p.m.

- 1. Scott Centrella moved, Robert Lessler seconded a motion to approve the minutes of the Easton Board of Selectmen Meeting of May 7, 2015. Motion carried unanimously.
- 2. No member of the public commented.
- 3. Robert Lessler Moved and Scott Centrella seconded to accept the bid for an Exmark LZX801GKA60600 mower from Bethel Mower for \$9,316 as recommended by Gary Simone of the Easton Parks and Recreation Department. Motion carried unanimously. Scott Centrella moved and Robert Lessler seconded to accept the bid of for a 2016 Ford F250 XL 4x4 Super Cab pickup for \$25,887. Motion carried unanimously.
- 4. Robert Lessler moved, Scott Centrella seconded to accept the bid for crack sealing from Seal Coating Inc., with Costello Industries as backup, as recommended by DPW director Ed Nagy in letter dated June 4, 2015 (attached to these minutes). Motion carried unanimously.

Robert Lessler moved, Scott Centrella seconded to accept the bid for chip sealing material A and B from Seymour Sealing, as recommended by DPW director Ed Nagy in letter dated June 4, 2015 (attached to these minutes). Motion carried unanimously.

Robert Lessler moved, Scott Centrella seconded to accept bids for road materials as recommended by DPW director Ed Nagy in letter dated June 4, 2015 (attached to these minutes). Motion carried unanimously.

Adam Dunsby moved, Robert Lessler seconded to add 4A to the agenda: Discussion and possible action on bids for 1) milling various roads and 2) conventional stainless steel dump body. Motion carried unanimously.

Scott Centrella moved, Robert Lessler seconded to accept the bid for milling of various town roads as recommended by DPW director Ed Nagy in letter dated June 4, 2015 (attached to these minutes). Motion carried unanimously.

Robert Lessler moved and Scott Centrella seconded to accept the bid for a conventional stainless steel dump body from Park City Truck Equipment, as recommended by DPW director Ed Nagy in letter dated June 4, 2015 (attached to these minutes). Motion carried unanimously.

5. Robert Maquat, Chair of the Planning and Zoning Commission, discussed the need to revise Easton's zoning regulations, which have never had a complete revision and are out of date in many respects. For instance, the regulations have been amended many times, but these amendments have never been incorporated into the body of the regulations. A revision would also make the regulations more user-friendly.

Planning and Zoning issued a request for qualifications (RFQ). Planning and zoning is recommending Planimetrics. The cost will be approximately \$30,000.

Scott Centrella moved and Robert lessler seconded to accept Planning and Zoning's recommendation to engage Planimetrics for the project. Motion carried unanimously.

- 7a. Adam Dunsby advised the Board that he had met with representatives from Sacred Heart. Sacred Heart wants to do more detailed analysis of the site.
