Adam Dunsby called the meeting to order at 7:30 p.m. Present: Adam Dunsby, Robert Lessler, and Kristi Sogofsky

- Kristi Sogofsky moved to approve the minutes of the Easton Board of Selectmen Meeting, November 15, 2018. Robert Lessler seconded. Motion passed unanimously.
- 2. Thirty three members of the public commented against the proposed Easton Ordinance Regarding Firearms.

- Kristi Sogofsky moved to approve the Driveway Variance and Indemnity Agreement for Belgium block apron at 4 The Circle, Easton, CT by EAJ Clinton Ave LLC. Robert Lessler seconded. Motion passed unanimously.
- Robert Lessler moved to accept the resignation of Kristi Sogofsky from the Library Board of Trustees. Adam Dunsby seconded. Motion passed unanimously.
- 6. After a discussion on the proposed Easton Connecticut Ordinance Prohibiting Waste Associated with Natural Gas and Oil Extraction, it was decided to send the proposed Ordinance to Ed Nagy for review.
- 7. Robert Lessler proposed a revised Easton Ordinance Regarding Firearms. This draft is different from the last one proposed. Kristi Sogofsky had concerns regarding some of the provisions. Adam Dunsby expressed his belief that many of the provisions are already covered by the State and Federal law. Robert Lessler will consider a re-write of the proposed ordinance.
- 8. Adam Dunsby presented the new town hall lectern built by Ben Burrell who built this as his Eagle Scout project. Adam also reported that 62 Easton employees attended the session on Sexual Harassment training provided by CIRMA. Also, explorations into Sacred Heart University building a baseball field on the Morehouse property have ended. Kristi Sogofsky said the library is reviewing the library facility use regulations. Robert Lessler asked for a cell tower update. Fiber is pulled but Verizon has additional steps to take before antenna is turned on.
- Kristi Sogofsky moved to adjourn at 9:37 p.m. Robert Lessier seconded. Motion passed unanimously.
