d. SWCCA Report

Phyllis Machledt, SWCCA representative (Southwestern CT Agency on Aging – http://www.swcca.org) Provided update on recent news. There is a new hospice site in Stamford, CT (1 Den Road) which recently opened. The annual meeting will take place on Thursday morning October 19th at Testo's. There is a program underway in Bridgeport through The Child & Family Guidance Center to address "Grandparents raising grandchildren" and will offer support group meetings and parenting classes. Contact is Gail Carroll at 203-394-6529, ext 3374. SWCCA is monitoring the situation on State of CT proposed budget cuts. Also, the company, ITN, a non-profit solution to senior transportation and people with visual impairments, which was based locally, is now defunct.

The CFA Members discussed some ideas previously presented for future dates as well as review earlier programs which were successful. A proposed MA project will be to correlate senior information from attendees at earlier events and create a contact list. Topics of First Responders and Technical computer presentations are also being revisited. CFA members are thinking of again doing some type of outreach for the upcoming holiday season.

Discussion will continue with regards for a new chairman, starting in January 2018.
