The meeting was called to order at 5:11 PM. Present were: Linda Dollard, Phyllis Machledt, Karen Martin, Lisa Tasi and Eileen Zimmerman / Municipal Agent – Senior Services.

# 1. Meeting Minutes

The minutes from the February 5, 2017 meeting were reviewed and unanimously approved by the members via a motion by Linda Dollard and Phyllis Machledt.

#### A. MCS Fund

A monthly report was received from Town Finance Direct Christine Calvert.

# B. Update on Medicare Savings Program / State of CT

Members discussed the current situation on the MSP. The program remains intact until July 1, 2018. There are parameters to meet for qualifying for one of the three Medicare Savings Programs (depending on income); DSS pays Medicare Part B premium each month. In addition, some enrollees will be covered for Medicare deductibles and co-insurance. Medicare Savings Programs are funded by Medicaid. As of January 31<sup>st</sup>, eligibility is extended through until July 1<sup>st</sup>, this is a result of Governor Malloy's direction to the Department of Social Services; and the General Assembly's passage of Public Act 17-1, January 2018 Special Session.

Members discussed the number of Easton Seniors receiving Senior Aid. Karen Martin will inquire via the Tax Relief for the Elderly to report back with information with regards to number of seniors/household income/tax relief.

A. Municipal Agent's Report – Eileen Zimmerman

Eileen is continuing her work with Seniors' Fuel Assistance and MSP questions. She met with the Lion's Club and is continuing participating in the Behavioral Health Subcommittee and Fairfield Social Services. She has met the local area's representative Margaret Watt and Easton representative, Sara Donovan, of the Department of Mental Health and Addiction Services. This is a key area that needs to be addressed for social work and psycho education. Eileen will be continuing the Bereavement Group with the assistance of Margarite Mcvay. This program will launch during the month of May. An additional setting will be focusing on Caregivers in the Fall 2018. Eileen has scheduled CHOICES counselors for individual appointments two mornings in March. A presentation on Medicare, in collaboration with SWCAA, will be held on March 24<sup>th</sup> at the Easton Library. Eileen is coordinating an Electronics workshop for Seniors at the Library on March 22<sup>nd</sup> as well as having some JBHS students contact Easton Seniors for a Social History project. There are other upcoming events scheduled for the Spring 2018.
