#### **DESCRIPTION OF PROPOSED ACTIVITY:**

If yes, describe the nature, extent and purpose of any change and explain why the proposed change is necessary. ## SEDIMENTATION AND EROSION CONTROL PLAN

Although an activity may be permitted as of right, appropriate sedimentation and erosion control measures may still be required. If the proposed activity involves any clear cutting of trees or the removal of ground cover or otherwise involves operations which pose a risk of creating sedimentation or erosion problems, submit six (6) copies of an appropriate sedimentation and erosion control plan. Particular attention should be given to control measures which are designed to prevent impacts to offsite wetlands and watercourses. Control measures to minimize unnecessary impacts to on site wetlands and watercourses should also be included.

The undersigned applicant and/or owner understand that this as of right request for determination is to be considered complete only when all information and documents required by the Agency have been submitted.

The undersigned consents to allow inspection of the above-identified property by agents of the Agency, at reasonable times, in connection with the review of this request for a declaratory ruling and, if necessary, during the course of the proposed activity. The agency reserves the right to request additional information as necessary to evaluate this request for a declaratory ruling and, as necessary, to evaluate compliance with the Agency's Regulations and applicable state law during the course of the proposed activity.
