MINUTES FOR THE TOWN OF EASTON CONSERVATION COMMISSION

EASTON TOWN HALL CONFERENCE ROOM A

Tuesday March 26th, 2019 7:30 p.m.

PRESENT: Dori Wollen, Chair; Cathy Alfandre, Steve Corti, Vivian Hardison, Steve Hume Elliot Leonard, Steve Montgomery (alternate).

ABSENT: Sarah Cwikla.

1. The Chair called the meeting to order at 7:31 p.m. Steve Montgomery was appointed to vote for Sarah Cwikla.

2. INLAND WETLANDS APPLICATIONS: a.) #19-545 -received 02/26/2019 + 65 days = 05/02/2019 -Town of Easton-Paine Open Space-Carriage Drive Entrance-Members of the Commission completed a site walk. Member Steve Corti presented the proposed maintenance to the Commission, The work to be done at this site is as follows: (1) 2 posts will be installed 10 feet from the curb line for a sign to this entrance to be erected in the future; (2)DPW has been asked to place pins delineating the boundaries of this entrance to the site; (3) In the interest of safety it may be necessary to place steps at the entrance to make the path "hiker friendly" and also to minimize maintenance; (4) hay bales or mulch will be placed on either side of the path to minimize erosion during the maintenance work, although this area is NOT in a regulated area; (5)Mr. Corti is going to donate 2 large cedar stumps which will be used for the sign posts; (6) He will work with the final bidder to complete this project. Cathy Alfandre moved to approve #19-545 with erosion controls if necessary. Steve Montgomery seconded the motion. VOTE: Application # 19-545 was approved by unanimous voice vote. **b.)** #19-546 -received 02/26/2019 + 65 days = 05/02/2019 -105 Asmara Way-**BALP LLC.** Warren Cartmell of Natural Designs advised Chair Dori Wollen by phone call that no one was prepared to come to the meeting on behalf of this application. Awaiting new information.

As he is volunteering his labor the only cost of this project will be for materials. Steve Corti moved to accept Mr. Logie's roof proposal, Cathy Alfandre seconded the motion. VOTE: The proposal of David Logie to repair the Main Entrance Kiosk roof was accepted by unanimous voice vote.

Member Steve Corti reported that on two different occasions he observed large numbers of dogs being walked without leashes. On both occasions he reminded the dogwalkers of the leash law, but was apparently ignored. The dogwalkers and their dogs had gained access to Paine Open Space through different entrances at different times of the day. A letter will be sent to the Dog Warden requesting drive by site visits.
