Mark Ochman was requested to provide a map showing which shows the "bigger picture" of the properties and access. Mr. Ochman will make a map of the 55 acre parcel showing the wetlands. The crossings and the limits of where the trees will be removed will be flagged for a site walk. The updated map is requested before a site walk is undertaken.
