MINUTES FOR THE TOWN OF EASTON CONSERVATION COMMISSION SPECIAL MEETING EASTON TOWN HALL – CONFERENCE ROOM A Tuesday, August 30, 2016 at 7:30 PM

PRESENT: Dori Wollen, Chair; Catherine Alfandre, Vice Chair; Elliot Leonard, Vivian Hardison ABSENT: Steve Corti, Steve Hume, Sarah Cwikla, Katherine Reed, Jamie Weinstein, Alternates

1. MEETING CALL TO ORDER: Chair, Dori Wollen called the meeting to order at 7:34pm.

2. INLAND WETLANDS APPLICATIONS

- A. I/W Permit App. #16-513, 80 Redding Road—Arvid Brandstrom, Owner/Applicant. Restore Wetland(s)/watercourse(s) and affected buffers. Received 6/14/16+65=10/22/16
- B. I/W Permit App. #16-514, 90 Redding Road—Arvid Brandstrom, Owner/Applicant. Restore Wetland(s)/watercourse(s) and affected buffers. Received 6/14/16+65=10/22/16 A. Moch, Soil Scientist, representing the applicant, together with Messrs. Brandstrom and D.Solvay were present. Ms. Moch presented a remediation plan for the combined properties focusing on four separate areas totaling 30,000 square feet. Area 1 will include trees and shrubs within the wetland/watercourse buffer; area 2 will get flowering meadow mix replacing the existing lawn; area 3 will get flowering meadow mix within the wetland buffer area and in area 4 new wetland will be created between wetland flags 20 and 24 as shown on the map received and stamped on 8/29/16. Questions remained as to the fate of the open pit full of construction debris. The site will be walked again and applicant will present proposals re this issue at the next meeting.
- C. I/W Permit App. #16-515, 30 Banks Road –Amerakon Partners LLC, Owner/Applicant.
 Install 24" culvert to cross stream with a farm road. Received 7/26/16+65=9/29/16.
 With all erosion controls in place and the crossing complete, upon motion by Catherine Alfandre and seconding by Elliot Leonard, the motion carried and the application was approved.
- D. After-the-fact I/W Permit App. #16-516, 90 Honeysuckle Hill Lane—Radu Popescu. Land clearing, remove six trees, build 10 plant beds, install fence. Received 8/9/16+65=10/13/16 Commissioners walked the site and reported that all activities on this property clear cutting and stumping followed by creating a vegetable garden were done within the 100' regulated area, without a permit. Most importantly, without proper erosion controls particularly because the entire area is on a slope. As an interim measure applicant was instructed to install a silt fence from the property line to about 5 feet away on the other side of the garden fence, within the garden fence and the tree log supposedly acting as erosion control. The site will be walked again to determine what other mitigation will be required re this project. Mr. Popescu was present at the meeting and was asked again to get a receipt from Aquarion confirming their receipt of the "after-the-fact" application.
