Juneteenth falls on Father's Day Sunday next year, and we should be cognizant of what other towns are doing and act accordingly. Could be opportunity for collaboration with other towns and groups, or to attract people from our neighboring towns.

6. Discussion and possible action:

- A. Transition from written public comment to verbal public comment
 - A group discussion quickly revealed unanimous support for the transition from written public comment, to live in-meeting public comment. Each member expressed their feelings about giving community members a voice, or "seat at the table". It was also pointed out that allowing verbal public comment is supporting diversity of thought on multiple topics. The discussion ended with how the procedural mechanics of public comment would work during regular meetings.
