APPLICATION FOR ANTIQUE, RARE OR SPECIAL INTEREST MOTOR VEHICLE

PURSUANT TO C.G.S. 12-71(b) & 14-1(1)(3) AS AMENDED BY PA 08-150

Passenger vehicles (01), combination vehicles (03), and motorcycles (12), 20 years or older that are defined as antique, rare or special interest motor vehicles, in accordance with the provisions of the Connecticut General Statutes 14-1, as amended by Public Act 08-150, Section 1, shall not be assessed more than \$500.

Definition:

C.G.S. Section 14-1, (3) "Antique, rare or special interest motor vehicle" means a motor vehicle twenty years old or older which is being preserved because of historic interest and which is not altered or modified from the original manufacturer's specifications.

Failure to file this original form with required color photos to the Assessor's Office <u>by</u> <u>4:30pm close of business on DECEMBER 28, 2023</u> will result in the vehicle being valued at retail based on NADA values according to state statutes. Emails/Scans/facsimile are not accepted. Provide full vehicle COLOR picture(s).
