## **S.W.C.A.A PRESENTAION**

## STATE TAX RELIEF PROGRAM

Qualifications for income for the **Elderly and Totally Disabled Tax Relief Program** applications are **Single \$34,600** and **Married \$42,200**. These levels are to be used for the 2014 Grand List Homeowner and Renter applications, 2015 Grand List Additional Veteran's applications and may also be used for any local option programs. You must provide your 2014 income along with Social Security Statement (1099) for 2014. Call the Assessor's Office for Applications and questions you might have at 203-268-6291.
