Open Enrollment for Medicare continues, my interest in starting a Bereavement Group has gathered interest and we are having our first group/meeting (see details below), and there's, as always, lots going on at The Senior Center (hibernating is for bears not seniors) so come on in and say hello!!!

MEDICARE & OPEN ENROLLMENT

Open Enrollment for changing your Medicare health or prescription drug coverage continues through **December 7**th, **2014.** If you haven't done so please start comparing your coverage with other options. In most cases, this may be the one chance you have to make a change to your health and prescription drug coverage.

For Medicare Part D and Medicare Advantage Plans the annual open enrollment period is *October 15th to December 7th, 2014* please do not think that you have until the end of the year to evaluate your plan and make a possible change. It is always a good idea to review to make sure that your medication will be covered on your plan's formulary. If you are a "snow bird", then check to see if your plan contracts for out-of-state coverage – if not, then ask your doctor if it is possible to write for a 90-day prescription. (Ask if he/she will continue to accept your plan).

<u>www.medicare.gov</u>. - Is a great website to browse. You can compare plans and make a decision on what to do. The drug formulary of each plan varies, so that is why you need to check the cost from year to year. What worked for you last year might not be the best decision for the coming year – avoid unexpected surprises!

Fuel Assistance

10 Warning Signs to look for:

- 1) Memory loss
- 2) Difficulty planning or solving problems
- 3) Trouble completing tasks
- 4) Confusion with time or place
- 5) Difficulty understanding visual images or spatial relationships
- 6) New problems with words in speaking or writing
- 7) Misplacing things and the loss of not being able to retrace steps
- 8) Decreased or poor judgment
- 9) Loss of interest in work or social activities
- 10) Mood or personality changes.

If you think that someone you know and love is experiencing any of these symptoms, or having cognitive difficulties please call your doctor and tell them your concerns. They will have an idea of what to do next, or refer you to someone who can further assess the situation.
